**TO: ALL SHIPOWNERS, OPERATORS, MASTERS AND OFFICERS OF
MERCHANT SHIPS, AND RECOGNIZED ORGANIZATIONS**

SUBJECT: Inmarsat Services under the Point of Service Activation Concept

PURPOSE

This Notice promulgates procedures required to activate, deactivate and update information regarding Inmarsat mobile earth stations (MESs) on Republic of the Marshall Islands (RMI) flagged vessels.

This Notice supersedes Rev. Jul/2021 and reflects the removal of PSA 1500 from §5.0.

APPLICABILITY

This Notice applies to all RMI-flagged vessels on which Inmarsat MESs are, or will be, installed.

REQUIREMENTS

- 1.0** A PSA is an entity authorized by Inmarsat with the approval of the RMI Maritime Administrator (the “Administrator”) to accept and process applications for MES service activation, assign Inmarsat Mobile Numbers and transmit customer service activation information to the Inmarsat Customer Activation group. The PSA works directly with the customer on service activation, in particular, and Inmarsat systems and services in general.
- 2.0** PSAs shall perform all functions regarding Inmarsat equipment activation, deactivation and maintenance of customer information held in Inmarsat’s Electronic Service Activation System (ESAS) for all vessels registered in the RMI in accordance with RMI laws and regulations.
- 3.0** A PSA shall inform the Administrator of all additions, deletions, and modifications to RMI MESs as quickly as possible with a change of flag by email to radio@register-iri.com.
- 4.0** It is imperative that this procedure be understood and followed by the PSA, shipowner and ship operator so that registration/deregistration of systems may be quickly accomplished for Long Range Identification and Tracking (LRIT) compliance.
