End note:

* RMI [Maritime Regulations \(MI-108\)](#) §1.11.1a limits registration of Private Yachts Limited Charter to more than 18 meters in length and less than 500 GT. The Administrator, or its authorized agent, may consider waiving the length limitation and other requirements upon demonstration that there is an absolute and genuine need for such a waiver. If this is granted, then the requirements in this column apply.
